

“McDonald’s® 2011 SANFL Grand Final Experience” Competition

Conditions of Entry

1. Information on how to enter and claim a Prize forms part of these Conditions of Entry.
2. Entry is open to all South Australian residents aged between 6 and 16 years old inclusive. The immediate families and members of the household of employees of the Promoter, their agencies or any other entity associated with this competition are not eligible to enter.

4. McDonald’s Restaurants in South Australia (except the Mount Gambier and Renmark restaurants but including the Broken Hill restaurant) are the only restaurants participating in this Promotion (“Participating Restaurants”).
