



SOUTH AUSTRALIAN COMMUNITY FOOTBALL LEAGUE INC AFFILIATION AGREEMENT

The **South Australian Amateur Football League Inc** makes application for affiliation with the **South Australian Community Football League Inc** (“**the SACFL**”). It is acknowledged that affiliation with the SACFL resulting from an acceptance of this application for affiliation by the SACFL will be subject to the following agreements acknowledgements and conditions:

1. The Affiliated League will at all times comply with and observe and procure and ensure that each of its officers servants agents, every Club which is a member of or which is affiliated with the Affiliated League and every officer official servant and agent of such Club will in all respects comply with and observe:
 - 1.1 the Laws of Australian Football;
 - 1.2 the Constitution Rules and Regulations of the SACFL;
 - 1.3 the Constitution Rules and Regulations of the South Australian National Football League Inc (“**the SANFL**”) to the extent that they are applicable;
 - 1.4 the Interstate Player Transfer Regulations published by the Australian Football League (“**the AFL**”) from time to time;
 - 1.5 any decision or determination of the bodies known as the AFL Commission, the SANFL Commission and any decision or determination of any Tribunal Commission or Committee of the SANFL which has been or which may in the future be made in relation to any matter which relates to the subject matter of this agreement, or which relates to any Club which is a member or affiliate of the Affiliated League, or to any officer official servant or agent of such Club.

2. That a copy of the Constitution and Regulations of the SACFL have been made available to the Affiliated League and that they are



reasonable for the purpose of protecting and promoting the game of Australian Football and that the restrictions contained therein are no more than are necessary to serve and protect the legitimate interests of the SACFL.

3. That the Affiliated League:
 - 3.1 is and will remain a properly constituted body with a Constitution approved by the League;
 - 3.2 has had its current Constitution approved by the SACFL;
 - 3.3 will submit any alteration to its Constitution to the SACFL for approval before coming into force;
 - 3.4 will submit to the SACFL:-
 - 3.4.1 by 31 January in each year a written application for renewal of its affiliation with the SACFL together with an annual affiliation fee of such amount as the SACFL determines from time to time;
 - 3.4.2 by 5 March in each year, a list of names and addresses of the officers of the Affiliated League;
 - 3.4.3 by 31 March in each year submit a list of the Clubs comprising the Affiliated League together with a list of the names and addresses of the president and secretary of each Club of the Affiliated League;
 - 3.5 will use its best endeavours to ensure that the game of Australian Football is conducted in a proper and efficient manner and that it will not act in any way calculated to or which can otherwise have the effect of bringing the game of Australian Football, the SACFL or the SANFL into disrepute;
 - 3.6 agrees to:-
 - 3.6.1 engage umpires appointed by the SANFL or appoint umpires from a panel of umpires approved by both the



SANFL Commission and the Community Football Board;

- 3.6.2 ensure that all Clubs affiliated with it have insured all senior teams in competitions conducted by it, for tragedy benefits insurance to a level as determined by the SANFL Commission from time to time;
- 3.7 agrees that the relationship between the Affiliated League and the SACFL is not and must not be construed or be deemed to be that of a partner, agent or trustee and that the Affiliated League will not bind or purport to bind the SACFL in any way nor pledge or purport to pledge a credit of the SACFL;
- 3.8 will assume sole and absolute responsibility for and indemnify the SACFL from and against all and any claims liabilities suits losses expenses actions causes of action responsibilities or damages by reason of any claim proceedings action liability or injury arising out of the conduct of its competitions or as a result of its relations with any third party or as a result of any breach by it of the Constitution Rules and Regulations of the SACFL or the SANFL;
- 3.9 will require all coaches to obtain a Level 1 Accreditation prior to the commencement of the second season of the appointment of the coach by a Club;
- 3.10 will use its best endeavours to ensure that all member or affiliate Clubs of that Affiliated League participate in all SACFL preferred supply agreements in existence from time to time, a list of which supplies will be made available at the commencement of each season or as and when arrangements are entered into with preferred suppliers;
- 3.11 acknowledges and recognises the SACFL and the SANFL as the overall controlling Leagues for all bodies which affiliate with the SACFL;
- 3.12 agrees that this agreement may be terminated and the affiliation of the Affiliated League will be terminated immediately:-
- 3.12.1 if it contravenes or fails to observe or perform any of the terms and conditions of its affiliation including without limitation the terms and conditions of this agreement, and the payment of any affiliation fee or any call or levy when due;
- 3.12.2 if a General Meeting of members of the SACFL determines by special resolution that the Affiliated



League has been guilty of conduct prejudicial to the interests of football the SACFL or the SANFL

AND the SACFL agrees with the Affiliated League and in consideration of the foregoing that it will act in good faith and administer its Rules and Regulations fairly and that it will from time to time amend same and make any new Rules or Regulations as it may consider appropriate to better regulate the conduct of Affiliated Leagues and the game of Australian Football conducted by those Affiliated Leagues.
